



GENERAL TERMS AND CONDITIONS

GAPA EVERESTING FESTIVAL

§ 1 Application – Scope

(1) The GAPA EVERESTING FESTIVAL 2027 (hereinafter referred to as GEF) is an event organized by PLAN B event company GmbH.

(2) The General Terms and Conditions (GTC) are published online at www.everesting-festival.com. The version valid at the time of registration shall form an integral part of the contract between the organizer and the participant.

§ 2 Participation Requirements – Safety Measures

(1) All healthy, experienced, and well-trained runners who have reached the age of 18 (exceptions see §3) are eligible to participate. Each participant bears full personal responsibility for their health condition. Participants must be aware of the distance and special characteristics of the event (nighttime conditions, cold temperatures, possible snow, rain, wind, elevation gain) and prepare accordingly. Participation is open to anyone who has properly registered and is in possession of an official GEF race number.

(2) Organizational measures will be communicated to participants by the organizer before the event begins. Participants must strictly follow the instructions of the organizer and its designated staff. In the event of misconduct that disrupts the orderly conduct of the event or endangers the safety of other participants, the organizer is entitled to exclude the participant from the event at any time and/or impose disqualification. Legally binding declarations towards participants may only be made by authorized representatives of the organizer. Participants expressly acknowledge and agree to comply with all COVID-19 measures imposed by the organizer and the authorities during the event period.

(3) All regulations, notices, and instructions contained in the event announcement and supplementary information constitute direct contractual obligations of the participant. Any claims arising in connection with the contract or the services provided by PLAN B event company GmbH must be asserted against PLAN B event company GmbH within one month after the contractually scheduled end of the GEF.

§ 3 Registration – Entry Fee – Registration Confirmation – Payment Terms – Refunds – Cancellation – Insurance – Transponder/Timing

(1) Registration is completed online via the event website. Registration is binding for participants. Upon successful completion of the registration process, participants will receive a confirmation, which constitutes and confirms the binding participation contract. Payment in full is due immediately upon registration. If the participation fee is not paid within four weeks of registration, the registration will expire and the starting place will be released.

(2) The participation fees for the individual competitions are as follows: from 01 February 2027

- SOLO EVERESTING: €275.00 per person → €299.00 per person
- 2-PERSON RELAY: €440.00 per team → €479.00 per team
- 3-PERSON RELAY: €630.00 per team → €669.00 per team
- 9-PERSON RELAY: €884.80 per team → €939.00 per team
- ZUGSPITZING: €120.00 per person → €139.00 per person
- GaPa500: €17.00 per person → €17.00 per person

Young people aged 14–17 may participate in the GaPa500 or relay events with written consent from their legal guardians and payment of a fee of EUR 15.00.

The exact services included with each entry package can be found on the website. Late registration on-site incurs an additional fee of €20.00. This does not apply to the GaPa500 (on-site entry fee: €20.00).

(3) Payment may be made using one of the following methods:

- PayPal
- Credit Card
- SEPA Direct Debit

(4) After receipt of registration and payment, the organizer will send a registration confirmation. The organizer reserves the right to disqualify and/or exclude any participant at any time if false personal information was provided during registration, if the participant is subject to a suspension imposed by a national or international federation, or if there is suspicion that the participant intends to compete after taking prohibited substances (doping).

(5) During registration, participants will only receive their race documents after submitting a digitally signed liability waiver. Collection of the race number and signing of the liability waiver must be carried out personally by the participant.

(6) PLAN B event company GmbH may exclude a participant from the event or terminate the contract if:

- the participant violates the regulations and/or rules and instructions (before or during the event);
- the participant significantly disrupts the event or endangers themselves or others;
- the participant fails to follow instructions issued by event management or staff;
- the participant acts in such a serious breach of contract that immediate termination is justified.

If PLAN B event company GmbH terminates the contract with a participant, it remains entitled to retain the participation fee.

(7) The following cancellation policy applies:

- Cancellations up to 31 March 2027: 50% of the entry fee will be refunded.
- After this deadline, no refund of the entry fee is possible. Ordered merchandise items are non-refundable and will be shipped to the participant's specified address after the event.
- Refunds will be processed within 14 working days after receipt of the written cancellation.

As race numbers are personalized, transfer to third parties is only permitted by the organizer and not by the participant.

It is strongly recommended that participants purchase private travel cancellation insurance and mountain rescue insurance.

(8) Any cancellation of registration by the participant must be submitted in writing.

(9) The timing transponder must be returned to the organizer after completion of the race (including in cases of early withdrawal). Failure to return the transponder will result in an invoice of €70.00, payable by the participant.

§ 4 Cancellation of the Event – Failure to Start

(1) If the event is cancelled, the participant does not start, or the race is abandoned for reasons beyond the organizer's control, the participant shall not be entitled to a refund or partial refund of the participation fee, nor to compensation for any other losses, such as travel or accommodation costs.

(2) Participants who are registered but fail to start are not entitled to a refund of the participation fee.

§ 5 Limitation of Liability

(1) By registering, the participant enters into a binding agreement to participate in the selected event organized by PLAN B event company GmbH and confirms, without further verification by the organizer, that they possess the special experience and knowledge required under Section 1 of the regulations.

(2) Any claims for damages against the organizer, regardless of legal basis, are excluded. This exclusion does not apply where the organizer, its legal representatives, or agents have acted intentionally or with gross negligence, or where liability is mandatory for injury to life, body, health, or essential contractual obligations.

(3) Participants agree to undergo any inspections or checks ordered by the organizer.

(4) Participants acknowledge and fully accept the participation requirements and the applicable regulations. They expressly confirm that they have read, understood, and accepted all rules, provisions, and conditions contained therein.

(5) By signing, the participant confirms participation in the event at their own risk and declares that adequate accident insurance coverage (including abroad) is in place.

(6) The organizer assumes no liability for health risks associated with participation in the event. By commencing participation, the participant confirms that there are no health concerns preventing participation and that their fitness level meets the requirements of such an alpine endurance competition. Participants are responsible for ensuring that their equipment complies with the regulations.

(7) The organizer accepts no liability for lost valuables, clothing, or equipment, including during baggage transport (clothing bags, drop bags, etc.).

(8) The organizer is not liable for reductions in performance resulting from the participant being wholly or partially prevented from participating due to legal regulations and/or governmental orders.

(9) If third parties are engaged by either the participant or the organizer, for example emergency rescue services, the resulting costs must be borne by the participant. The organizer reserves the right to recover any such costs from the participant.

(10) Participants are strongly advised to obtain private international health insurance covering helicopter rescue operations and repatriation transport.

§ 6 Collection and Use of Data

(1) By registering, participants consent to the collection of the data provided in the registration form for timing, ranking, and result processing, including transmission to third parties and publication on the internet.

(2) Personal data provided during registration will be stored and processed solely for the purpose of organizing and administering the event. This applies particularly to data required for payment processing (§ 28 German Federal Data Protection Act). By registering, participants consent to such storage and processing.

(3) Participants agree that photographs, videos, and interviews taken in connection with their participation may be used and published in radio broadcasts, television, print media, books, and social media (e.g., Instagram, the event website, PLAN B website, YouTube, etc.) without compensation. Participants also consent to the transfer of their personal data for the purpose of sending photographs produced by a company commissioned by the organizer. However, this consent does not imply any obligation to purchase such photographs.

(4) Participants agree to the publication of their surname, first name, year of birth, team name, race number, and results (rankings and times) in all event-related print media (participant lists, results lists, etc.) and electronic media, including the internet.

(5) Participants may object to the transfer and publication of their personal data by notifying the organizer in writing, by fax, or by email.

(6) By providing an email address, participants consent to PLAN B event company GmbH using it to send event-related information.

§ 7 Limitation Period

Any claims by participants against PLAN B event company GmbH, regardless of legal basis, shall become time-barred one year after the contractually scheduled end of the event.

The place of jurisdiction for disputes arising from the contract with participants shall be Munich, Germany. The entire legal and contractual relationship between PLAN B event company GmbH and the participant shall be governed exclusively by German law.
